Course Description

An intermediate-level quantitative course that focuses on the layouts, calculations, and interpretations of Between, Within, and Mixed Model Analyses of Variance. A second focus of the course is Nonparametric statistics.

Objectives of the Course

- Articulate the difference in data layouts for Between, Within, and Mixed Model Designs.
- Describe the calculations and interpretations associated with Between, Within, and Mixed Model Designs.
- Interpret computer printouts of Between, Within, and Mixed Model Designs.
- Describe and interpret the basic Nonparametric Statistics.
